SUFFOLK COUNTY COUNCIL (PARISH OF STANTON) (VARIOUS ROADS) (TEMPORARY CLOSURE FOR A SPECIAL EVENT) ORDER 2024

WHEREAS Suffolk County Council ('the Council') being the highway authority for the roads specified in this Order, is satisfied that traffic on the said roads should be restricted to enable the Stanton Parish Council to hold the Royal British Legion Remembrance Sunday (hereinafter referred to as 'the event').

NOW, THEREFORE, the Council in exercise of its powers under Section 16A(2) of the Road Traffic Regulation Act 1984, as amended by the Road Traffic Regulation (Special Events) Act 1994 and of all other enabling powers, hereby makes the following Order:

- 1. The provisions of this order will operate as and when required at the discretion of the police and event organisers.
- 2. Except as provided in Articles 3, 4 or 5, no person shall, except upon the direction or with the permission of a police constable in uniform, a police community safety officer or a civil parking enforcement officer cause or permit any [motor] vehicle to proceed in road or roads specified in schedule 1.
- 3. Nothing in Article 2 of this Order shall make it unlawful for a person to cause or permit any motor vehicle to proceed in the length of road referred to in that Article if the vehicle is taking part in the event in an official capacity.
- 4. Nothing in Article 2 of this Order shall make it unlawful for a person to cause or permit any motor vehicle to proceed in the length of road specified in that Article if the persons and vehicles taking part in the event have passed and a police constable in uniform or anyone acting with his authority has removed the signing.
- 5. (1) Insofar as safe passage permits, nothing in Article 2 of this Order shall make it unlawful for a person to cause any motor vehicle to enter or proceed in the length of road referred to in that Article in order to gain access to or egress from premises adjacent to or accessible only from that length of road.

(2) Nothing in Article 2 of this Order shall make it unlawful for a person to cause or permit any vehicle to proceed in the lengths of road specified in this Order if the vehicle:

(i) is to be used for police operational, fire brigade or ambulance purposes;

(ii) cannot conveniently be used for such purpose in any other road and is to be used in an emergency in connection with any of the following operations, namely: the laying, erection, alteration or repair in or on land adjacent to the said length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications system as defined in the Telecommunications Act 1984;

- 6. This Order is made on condition that Stanton Parish Council will:
 - a) advise all residents and businesses affected by the closure of the aforesaid road or roads;
 - b) keep the local police informed of all proceedings related to the event;
 - c) indemnify the Council from and against all legal liability in respect of loss, damage, actions, proceedings, suits, claims, demands, costs, damages, liability and expenses in respect of any injury to or death of any person or destruction of or damage to any

property (whether movable or immovable) by reason of or arising in any way directly or indirectly from the holding of the event;

- d) reinstate and make good to the satisfaction of the Council any damage caused as a result of the holding of the event; and
- e) pay to the Council a fee for legal and administration costs as shall be agreed with the Council.
- 7. Nothing in this Order shall prevent access by vehicles being used for police operational, fire brigade or ambulance purposes.
- This Order shall be operative on 10th November 2024 and shall continue in force for a maximum period of 3 days (unless extended by the Secretary of State). It may be cited as the Suffolk County Council (PARISH OF STANTON) (VARIOUS ROADS) (TEMPORARY CLOSURE FOR A SPECIAL EVENT) ORDER 2024.
